Otto L. Mertz and William Ballman Drowned at Lake

Pair With Mrs. Mertz and Mrs. Henrietta Meyer on Holiday Trip to Three Lakes, Lose Life After Boat Capsized Twice

Otto L. Mertz, president of the Greenfield Avenue Advancement association and head of the Mertz-Knipel Ford agency and William Ballman are dead as a result of one of the saddest and most peculiar water fatalities that have occurred in some time. The accident took place at Three Lakes, Wis., Wednesday noon.

Mr. Mertz and Mr. Ballman accompanied by Mrs. Mertz and Mrs. Henrietta Meyer, her mother, left for Three Lakes Last Saturday on a holiday trip to the home of Welcome Meyer, brother-in-law to Mr. Mertz. On Wednesday the four went on a fishing excursion. They were fishing in deep water about twenty feet from the shore when Otto in casting upset the boat.

Upset Again

The four righted the boat and all got inside with the exception of Otto. When he attempted to climb in the boat was again upset. Mr. Ballman's clothing became entangled in the Evinrude motor that was attached to the boat and he was dragged under the water.

Otto told his wife to go for help to rescue his uncle. She swam to shore and met two young men who could not swim but with their assistance and the aid of Mrs. Meyer who had remained on the upturned boat. The body was dragged to shore. Ballman's body was underneath and he was drowned. Mr. Mertz's body was recovered almost instantly but life was found extinct. It is believed that he died of heart disease.

Funeral Saturday

The bodies of the two arrived in West Allis on Thursday. Burial will take place Saturday in charge of the Rev. Gustav Stearns, pastor of the Lutheran church of the Ascension.

Mr. Mertz was one of the best known, most popular and most progressive businessmen in West Allis and his loss is felt by the entire community. He was born at Reeseville Wis., thirty-four years ago and has been in business in West Allis for over a decade. He first kept the barbershop at present connected with the Commercial hotel. Later he went into the confectionary business where the Arc parlor is now located. Then he took over the agency of the Alemite Lubrication System. Then started the Mertz Tire Shop of which he was still part owner and a short time ago together with Mr. Knipple bought out the Tobin-Sutton Ford Agency.

When the Greenfield Avenue Advancement association was formed some time ago he was unanimously elected president as it was felt that his business ability and his desire to boost everything that pertained to West Allis made him the man to put the new organization on its feet.



Mr. Mertz was a member of the Excelsior lodge, Order of Masons. They will have charge of the funeral Saturday afternoon, assisted by the Rev. Stearns.

Mr. Ballman, 62 years old, who was brother of Mrs. Meyer, mother of Mrs. Mertz was well known in West Allis. He was one of the city's best-known saloonkeepers, but at the time of his death he was retired and was living with Mr. Mertz.

Upset Again

The four righted the boat and all got inside with exception of Otto. When he attempted to climb in the boat was again upset. Mr. Ballman's clothing became entangled in the Evinrude motor that was attached to the boat and he was dragged under the water.

Otto told his wife to go for help to rescue his uncle. She swam to shore and met two young men who could not swim but with their assistance and the aid of Mrs. Meyer who had remained on the upturned boat. The boat was dragged to shore. 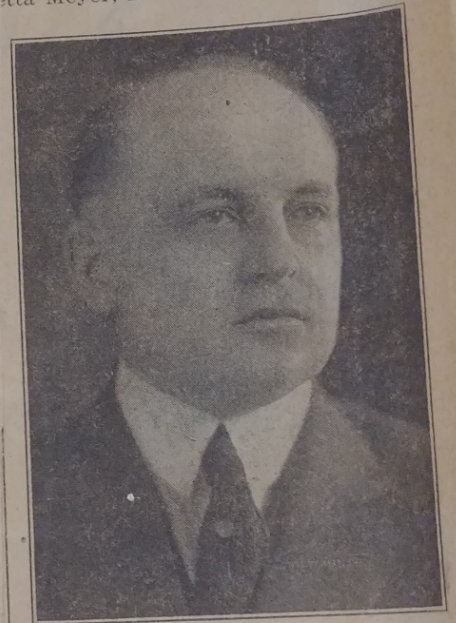

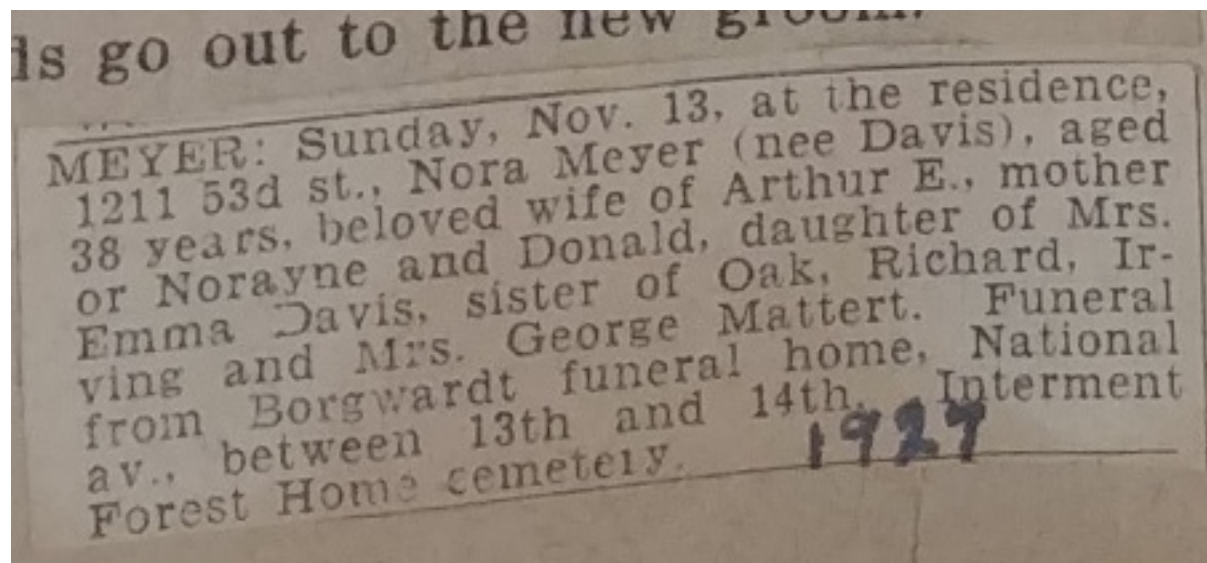

Man Loses Balance
